WHAT PROJECTS QUALIFY?















Scrap and replace/repower diesel (or diesel/gasoline UTV) off-road equipment over 25 hp:

- Construction, Industrial, and Cargo Handling
- Agricultural (includes replacing UTV/tractors under 25 hp with electric UTV)
- Marine engines (repower only)
 - Commercial harbor craft may also qualify for repower, retrofit, or replacement from Goods Movement Emission Reduction Program (GMERP) funds; see GMERP details at: http://tinyurl.com/sdapcd-gmerp
- Locomotives

Scrap and replace/repower diesel or natural gas on-road vehicles:

- Heavy-duty trucks over 14,000 pounds GVWR (replacement trucks received by December 31, 2022)
 - Trucks over 16,001 GVWR may also qualify for Goods Movement Emission Reduction Program (GMERP) funds; see GMERP details at: http://tinyurl.com/sdapcd-gmerp
- School and transit buses
- Public agency, utility, solid waste collection, and emergency vehicles

Install new infrastructure:

- Battery Charging stations supporting the above equipment types
- Natural Gas and Hydrogen fueling stations supporting the above equipment types

Disadvantaged Community Projects:

- Disadvantaged communities marked pink or pink/blue stripe in this map: https://bit.ly/ej-map
- Zero-Emission Lawn and Garden Equipment, low/no formaldehyde composite wood furniture, and enhanced air filters in K-12 schools located in disadvantaged communities
- Various stationary source projects located in disadvantaged communities

WHAT ARE THE FUNDING LEVELS?

Funding depends on several factors, including cost-effectiveness (new equipment cost divided by pounds of emissions saved by using new equipment), equipment location, and whether new equipment is zero-emission.

Some examples of grant funding levels:

- Up to 80% to replace a tractor or other off-road equipment
- Up to 75% to replace a gas/diesel UTV or under 25 hp tractor with an electric UTV
- Up to \$400,000 to replace a school bus with a zero-emission school bus (more in disadvantaged communities)
- Up to 70% to replace zero-emission lawn and garden equipment at K-12 schools in disadvantaged communities
