FREE Unwanted Agricultural Pesticide Disposal Event

The County of San Diego Department of Agriculture, Weights and Measures (AWM), in partnership with the California Department Pesticide Regulation, California Agricultural Commissioners and Sealers Association, and County Department of Public Works is holding a one-day pesticide disposal event for agricultural growers! The County has contracted with a vendor to provide **FREE** disposal of unwanted agricultural use pesticides. Unwanted and outdated pesticides pose a potential hazard to human health and the environment. Don't miss this opportunity!

Who can participate: Growers who hold current Operator Identification Numbers or Restricted Materials Permits and have production agricultural operations in San Diego county are eligible to participate.

What pesticides are eligible: Unwanted, unregistered, banned, and restricted pesticides labeled for agricultural production use.

How does the process work:

- Complete the enclosed application and email it to: PRP.AWM@sdcounty.ca.gov by **May 27, 2022**.
- AWM will review your application and contact you regarding eligibility. *Note: Banned, restricted and Danger category pesticides will be given highest priority.*
- AWM will notify you which of your pesticides have been selected for this event and provide you with an approved Hazardous Materials Manifest and detailed information for the day of the event.
- Eligible participants must safely transport the approved pesticides and Hazardous Materials Manifest to the event!

Any pesticides not pre-approved by AWM or other hazardous materials (paint, batteries, medications, etc.) that are brought to the event will not be accepted. This event is **NOT** for the disposal of empty pesticide containers.

When is the event: June 11, 2022

Where is the event: Valley Center, California

Submit your application early. Applications will be processed in the order they are received. Photographs of each pesticide will be requested. To ensure equity, the amount of pesticides approved per grower may be limited.

To protect health and the environment, we are providing this unique opportunity to safely dispose of unwanted, unregistered, banned, and restricted pesticides for **FREE!**
