

Approximately 6 miles east of I-15, KRSEK Ranch is located east of Pala Loma Dr along San Luis Rey Dr in the Couser Canyon area of Valley Center.

The property is fully fenced with gated access providing a private and secure operation. The base rate for agricultural water in VCMWD is currently ±\$1,880 per acre foot, net of pumping rates and service charges.

PLANTINGS

The property is planted to a mix of lemons and avocados and is certified organic by the respected Organic Certifiers. There are approximately 650 Eureka lemon trees and 300 Hass avocado trees. The property is professionally managed by Brothers Farm Labor, who could remain contracted for continued labor.
